of the Rector of the Nicolaus Copernicus University in Toruń

of 1 June 2020

**on rates for one hour of classes and tuition fees at full time and part time studies
in the Bydgoszcz part of the Nicolaus Copernicus University for foreigners commencing
studies in Polish from the academic year 2020/2021**

Pursuant to § 5 sec. 1 of resolution no. 119 of NCU Senate of 24 September 2019 on the principles of charging fees for educational services and the procedure and conditions of fee exemption (NCU Legal Bulletin of 2019, item 301)

it is ordered as follows:
