- f) for each guest staying overnight in Student House no. 1 and Student House no. 2 in a resident's room, upon permission granted by the Student's House Manager -11.00 PLN per night,
- g) for each guest staying overnight in Student House no. 3 in a resident's room, upon permission granted by the Student's House Manager 26.00 PLN per night,
- 2. In the case of a one-time stay exceeding five days (nights), the fee rates determined in points **a-e** for Student House no. 2 and Student House no. 3 are reduced by 20% for the sixth and subsequent days, regardless of the room standard.
- 3. In the case of accommodating a group of over five persons, the fee rates determined in point  $\mathbf{e}$  for Student House no. 2 and Student House no. 3 are reduced by 20% per day, regardless of the room standard.

4. Notwithstanding the provisions specified in sec. 1-3, a person who has been granted a place in a student house is required to pay the monthly fee instead of the daily fee in cases when the amount of monthly fee is lower than the total amount of payment due calculated on the basis of the daily fee.

§ 4

The fee for using the laundromat in a student house is PLN 4.00 gross in Toruń and PLN 3.00 gross in Bydgoszcz for one washing cycle (does not pertain to Student House no. 3 in Bydgoszcz).

§ 5

The fees specified in § 1 and § 3 are net values. In cases when value-added taxation is necessary, the relevant VAT amount shall be added to the fees.

§ 6

- 1. Directive no. 127 of the Rector of the Nicolaus Copernicus University in Toruń of 16 August 2018 on accommodation fees in the Student Houses of the Nicolaus Copernicus University shall expire.
- 2. This Directive is effective as of 1 January 2015.
